

A challenge to the validity of the judgment of conviction must be raised in a post-conviction petition for a writ of habeas corpus filed in the

SUPREME COURT OF NEVADA district court in the first instance.¹ NRS 34.738(1); NRS 34.724(2)(b). Accordingly, we

ORDER the petition DENIED.
