ORDER OF AFFIRMANCE

This is a proper person appeal from an order of the district court dismissing a post-conviction petition for a writ of habeas corpus.¹ Second Judicial District Court, Washoe County; Robert H. Perry, Judge.

Appellant filed his petition on August 26, 2011, more than four years after entry of the judgment of conviction on April 5, 2007. Thus, appellant's petition was untimely filed.² <u>See</u> NRS 34.726(1). Appellant's petition was procedurally barred absent a demonstration of cause and undue prejudice. <u>See</u> NRS 34.726(1).

In an attempt to overcome the procedural bars, appellant claimed that he was actually innocent. Appellant did not demonstrate actual innocence because he failed to show that "it is more likely than not

that no reasonable juror would have convicted him in light of . . . new evidence." <u>Calderon v. Thompson</u>, 523 U.S. 538, 559 (1998) (quoting <u>Schlup v. Delo</u>, 513 U.S. 298, 327 (1995)); <u>see also Pellegrini v. State</u>, 117 Nev. 860, 887, 34 P.3d 519, 537 (2001); <u>Mazzan v. Warden</u>, 112 Nev. 838, 842, 921 P.2d 920, 922 (1996). Appellant failed to support his claims with specific facts, that if true, would entitle him to relief. <u>Hargrove v. State</u>, 100 Nev. 498, 502, 686 P.2d 222, 225 (1984). We therefore conclude that the district court did not err in denying appellant's petition, and we

ORDER the judgment of the district court AFFIRMED.
