ORDER DISMISSING APPEALS




The notices of appeal were untimely filed. NRAP 4(b); Edwards v. State, 112 Nev. 704, 918 P.2d 321 (1996). Because an untimely notice of appeal fails to vest jurisdiction in this court, Lozada v.
