Nevada, with JUDGE JERRY WIESE presiding; Plaintiffs SANDY WHITEHOUSE, JOHN WHITEHOUSE and S&J INVESTMENTS, LLC appeared by and through their attorney MARGARET E. SCHMIDT, ESQ, of the law firm, MAIER GUTTERREZ AYON; Defendant

- I. At the hearing on February 13, 2014, counsel for Wells Pargo advised the Court that the Honorable Judge Susan Johnson of Department XXII ruled on an identical case involving the same property, requesting the same relief, and addressing the same legal issues in Case No. A-13-691390-C (the "First Action").
- 2. The First Action was fully and finally adjudicated on January 7, 2014, and the case was dismissed on the merits and in its entirety (the "Original Dismissal Order").
- A Notice of Entry of the Original Dismissal Order was filed and served on February 4, 2014.
- 4. Because the issues decided in the First Action are identical to the issues presented in the pending litigation, involved the same property, involved the same parties or their privies, and was fully and finally adjudicated on the merits, the doctrines of issue and claim preclusion has the pending action. See Five Star Capital Corp. v. Ruby, 124 Nev. 1048, 1054-55 (2008).
- Pursuant to these findings, IT IS ORDERED, ADJUDGED, AND DECREED that
 Plaintiff's Motion for Preliminary Injunction is DENTED.

Appellant in the underlying action purchased the subject property at a homeowners association foreclosure sale conducted pursuant to NRS 116.3116 et seq. NRS 116.3116 provides an association with a statutory lien against the unit owners' unit. See NRS 116.3116(1). Sections 116.31162 through 116.31168 of the NRS describe the enforcement of an association lien through non-judicial foreclosure. While an association's lien is generally subordinate to a first deed of trust, NRS 116.3116(2) provides for a portion of the association's lien (the "super-priority" lien) to be prior to a first deed of trust upon foreclosure of the unit. Accordingly, when an association forecloses its lien that contains super-priority amounts, any first deed of trust is extinguished, along with any junior security interest.

Thus, Appellants' initiated a lawsuit for quiet title and injunctive relief on November 7, 2013 against Wells Fargo and National Default. However, following the court's denial of Appellants' motion for preliminary injunction, on December 5, 2013, Wells Fargo and National Default foreclosed on the subject property and sold it to Fannie Mae. An order was never entered from which Appellants could appeal. Thereafter, the court granted Quality Loan's motion to dismiss and Respondent's case was dismissed. An appeal followed (Case No. 65169).

Because the purchaser of the subject property, Fannie Mae, is not a party to the original lawsuit, any relief granted by the Nevada Supreme Court on appeal would not enjoin it. Accordingly, Appellants initiated the instant lawsuit for wrongful foreclosure and injunctive relief on January 16, 2014 against Fannie Mae, Wells Fargo and National Default. On January 17, 2014, Appellants filed a motion for preliminary injunction in order to enjoin Respondents from transferring the property to yet another party. and interfering with Appellant's enjoyment of the property. On February 10, 2014, just three days prior to the hearing, Wells Fargo filed an opposition thereto as well as a countermotion to dismiss. On February 13, 2014, Judge Wiese denied Appellant's motion for preliminary injunction and granted Wells Fargo's countermotion to

dismiss based on principles of res judicata. The order granting Wells Fargo's countermotion was entered on March 7, 2014.

In Nevada, "res judicata precludes parties or those in privity with them from relitigating a cause of action or an issue which has been finally determined by a court of competent jurisdiction" (University of Nevada v. Tarkanian, 110 Nev. 581, 598, 879 P.2d 1180, 1191 (1994)) and applies when the following requirements are met: (1) the issue decided in the prior litigation must be identical to the issue presented in the current action; (2) the initial ruling must have been on the merits and have become final; and (3) the party against whom the judgment is asserted must have been a party or in privity with a party to the prior litigation. *Id.*

However, the instant lawsuit appealed from included a different cause of action (wrongful foreclosure) and a different party (Fannie Mae). Accordingly, this appeal followed.
