## ORDER OF AFFIRMANCE

This is a proper person appeal from a district court order dismissing a legal malpractice action. The district court concluded that no attorney-client relationship existed between respondent Lawrence D. Wishart and appellant Kevin J. Fitzsimmons because they did not have a contract and Wishart never appeared as an attorney of record for Fitzsimmons in any action.

An order granting an NRCP 12(b)(5) motion to dismiss for failure to state a claim upon which relief can be granted is subject to rigorous appellate review.<sup>1</sup> This court construes the pleadings liberally and accepts all factual allegations as true.<sup>2</sup> A complaint should not be dismissed "unless it appears to a certainty that the plaintiff is not entitled to relief under any set of facts which could be proved in support of the claim."<sup>3</sup> A legal malpractice action requires the existence of an attorney-client relationship, along with a duty owed to the client, a breach of that duty, the breach proximately causing the client's damages, and actual loss or damage.<sup>4</sup>

Having reviewed the record, we conclude that the district court did not err in dismissing the complaint. Appellant failed to allege sufficient facts demonstrating that an attorney-client relationship existed between him and respondent in order to sustain a legal malpractice action. According, we

ORDER the judgment of the district court AFFIRMED.<sup>5</sup>
