Eighth Judicial Dist. Ct., 140 Nev.Adv.Op. 8 (2024). Consent of the parties is not a prerequisite to such coverage. SCR 240.

Accordingly and good cause appearing, Mr. Falconi's request to conduct electronic coverage of the preliminary hearing is GRANTED. Further, said grant shall be applicable to any other dates/times to which the preliminary hearing may be rescheduled and Mr. Falconi will not be required to file a subsequent request for electronic coverage for such preliminary hearing date(s). The Court, however, would appreciate notice of Mr. Falconi's intent to conduct such coverage, so that the Court can ensure the facilities are prepared for his presence. If future circumstances warrant, the parties may file a

1	written motion to revoke/rescind this grant.
