With an extensive experience in criminal, civil and administrative law, she is uniquely qualified to serve on the District Court. In rendering decisions she can draw upon her experience as a substance abuse counselor, a prosecutor, a business woman, an attorney representing business owners, as Nevada's Consumer Advocate or commissioner. #### For District Court Judge Dept 22: Jacob Hafter

Jacob was born and raised in Las Vegas. He left to attend George Washington University, School of Medicine, and received a Bachelor of Science degree in Emergency Medical Services Management. He received his law degree from Case Western Reserve University, School of Law in Cleveland, Ohio and was one of the first graduates to receive a certificate in Health Law. During law school he also enrolled at Cleveland State University where he completed a Master's of Science degree in Health Science. Jacob's legal career began in New Jersey where he represented health care providers, municipalities and businesses, and developed a niche practice in Administrative, Regulatory and Transactional Health Care law. in January 2005. Four years later she was elected as District Court Judge in Department 23, where she currently presides hearing civil and criminal cases. Judge Miley was born and raised in Austin, Texas. She graduated from Texas A&M University in 1993 with degrees in Journalism and Marketing and attended law school at California Western School of Law in San Diego, California. As part of her law studies, she completed a clerkship with the Honorable Nancy C. Oesterle, Justice Court, Las Vegas Township. Following the clerkship, she commenced her law career in Las Vegas where she enjoyed diverse practice areas including civil litigation, probate and estate litigation, family law, criminal law, and juvenile law. Additionally, she has also been involved with numerous local charities including Junior League of Las Vegas and assisted in authoring and passing the Safe Haven for Babies Legislation. Finally, she has also been involved with the Jean Nidetch Women's Center and UMC Children's Miracle Network.

#### District Court Judge, Dept. 24: Joe Hardy Jr.

Joe Hardy, Jr. is a third-generation Nevadan graduating from Boulder City High School. Joe was accepted to Brigham Young University with a full tuition scholarship. He remained at BYU for law school and graduated Cum Laude. Upon graduation, Joe returned to Las Vegas and now lives in Henderson with his wife and two sons. Joe is the comanaging partner of the Las Vegas office of Gordon & Rees, one of the 100 largest law firms in the country. He represents individuals and business entities in all types of civil litigation, both as plaintiffs and as defendants. In 2010, Joe was appointed to serve on the Nevada Taxicab Authority board and his appointment was renewed by Governor Sandoval in 2013. Joe is an arbitrator for the Better Business Bureau and a contributing author to the Revised Nevada Jury Instructions. Joe has always volunteered for pro bono work and has done extensive volunteer work for the Boy Scouts of America. Joe currently serves as chair of the Las Vegas chapter of the J. Reuben Clark Law Society.

#### For District Court Judge (Family Div) Dept D: Judge Robert Teuton

Judge Teuton earned his undergraduate degree from St. Mary's College in Moraga, California and graduated from Texas Tech Law School where he served as Comments Editor on the Law Review. He moved to Las Vegas in 1977 and after a judicial clerkship worked as a criminal prosecutor under District Attorneys George Holt, Bob Miller, Rex Bell and Stewart Bell. He was Assistant Director and Acting Director of Clark County Juvenile Court Services under Judges Mc Groarty and Shearing. District Attorney David Roger appointed him one of two Assistant District Attorneys in 2003. The Judicial Selection Commission unanimously recommended his appointment to the bench in 2008 and, following his appointment by Governor Gibbons, was elected to office in 2010. He received an 81% retention rating in the 2013 LVRJ poll of practicing attorneys, 15% higher than the Family Court average and 4th highest on the Family Court bench. He currently handles child abuse, neglect and termination of parental rights cases. He and his wife, Sylvia, live in Anthem and have two children: Robert at (UNLV) and Isabel at (Nevada State High School).

#### For District Court Judge, (Family Div) Dept F: Judge Bill Gonzalez

Judge Gonzalez was appointed in 2009 to the Family Court, Department F. Then in 2010, Clark County voters reelected Judge Gonzalez by a landslide. Prior to this he had a successful career as an attorney. Mayor Oscar Goodman appointed Judge Gonzalez to serve on the City of Las Vegas Housing Authority Board in 2003. He served as vice chairman of the Board from 2003 to 2007, helping manage the authority's \$64 million annual budget. During his tenure, he worked to provide affordable housing for veterans, low-income families, the disabled, and the elderly. Judge Gonzalez and Ana Maria, his wife of 27 years, have four children ages 13 to 25. They have made Southern Nevada their home since 1997. During the early years of his marriage, Judge Gonzalez also put himself through college while working full-time. Judge Gonzalez has a Bachelor's Degree in Business from Redlands University (California 1991), an MBA from the Monterey Institute of International Studies (California 1992), and a Law Degree from the J. Reuben Clark School of Law (Utah).

#### For District Court Judge (Family Div) Dept J: Rena Hughes

Rena came to Las Vegas in 1989 when she began practicing family law. Rena attended East Central University in Ada, Oklahoma and received a degree in Political Science in 1985. She then attended the University of Oklahoma Law School and graduated in 1988. Rena has received Pro Bono awards for her hours of work on behalf of indigents and has also been a volunteer attorney for the Jewish Family Services. For 13 years Rena served as an Arbitrator and Chairperson for the State Bar of Nevada Fee Dispute Committee. She is currently a Settlement Hearing Master for family court, a Pro Tem Judge, and is also a certified Family Law Specialist. In an independent, anonymous rating system for attorneys with Martindale Hubble, Rena was rated by her peers and local judges as "Preeminent" or AV. Rena is a volunteer for Safe Nest, is a tutor for adult literacy through the Clark County Library system, and is a Sunday school teacher. She also enjoys cooking, baking, and riding her Harley Davidson motorcycle.

#### For Constable of Henderson: John Stites

John retired from the Los Angeles County Sheriff's office where he initially served as Deputy Sheriff for 8 years and was then promoted to Sheriff Sergeant in which he served for 21 years. Prior to this, John served in the U.S. Army for 27 years in Special Forces and Airborne Units reaching the rank of 1st Sergeant. After a search of the western United States with his wife, Robin, they decided that Henderson, Nevada was the city they wished to live in and have done so for four years. John has been active in politics for more than 30 years and currently serves as a Governor appointee on the California Citizens Compensation Commission until 2015. President's Message May 2014



Much as I love sharing what's going on and bragging about our club, this month I am compelled to discuss an issue about which all Nevadans need to become aware. The **Margin Tax Initiative** is a complex tax increase proposal that will appear on Nevada's 2014 statewide general election ballot. It is now being called an **Education Initiative**, but it is simply another tax clad in education clothing. If this initiative passes it . .

- 1. Would impose a huge new tax on large employers and thousands of small business owners throughout Nevada. Every business with total annual GROSS revenues exceeding \$1 million would be subject to a new 2% Margin Tax regardless of whether that revenue is actually profit. It would severely damage our state's struggling economy causing the loss of thousands of existing jobs and making it nearly impossible to attract new businesses and jobs to Nevada.
- 2. Would make Nevada one of the highest taxed states in which to operate in the U.S. Imposing the initiative's tax on top of the state's existing Modified Business Tax would create the equivalent of an almost 15% state corporate income tax, nearly twice as high as the corporate income tax rate in California.
- 3. Would NOT guarantee that the Margin Tax revenues would actually be used to improve Nevada's educational system. Technically, the dollars generated from the measure would be put into the "Distributive School Account," which is used to fund K-12 education. However, under the initiative, the state legislature could simultaneously take money from the regular budget away from education to fund other things.
- 4. Would **create a tax "fiscal cliff."** A business making one penny less than \$1 million in gross revenues would pay no tax. A business that grossed one penny more than \$1 million would pay the 2% Margin Tax based on the entire million whether the business made a profit or not. The extra burden of the proposed Margin Tax would force these companies to cut jobs and could even put many of them out of business.
- 5. Would **cost millions of taxpayer dollars for the state government to interpret and implement** and it would tie the state up in lawsuits for years due to the legal complexities and drafting ambiguities. The Margin Tax Initiative contains 84 sections of complicated legal and technical language that would create a logistical and legal nightmare for businesses to navigate. The initiative language doesn't match federal tax compliance definitions, so businesses would now be required to maintain two sets of books, one for federal law and one for the new Margin Tax adding an additional cost burden.

Proponents claim that the \$1 million gross revenues threshold would protect small businesses. In reality, the Margin Tax Initiative would hurt thousands of small businesses that have total annual gross revenues of over \$1 million but also have high overhead and very small profit margins, such as family-owned restaurants, medical clinics, daycare centers, repair shops, veterinarians, janitorial services, ranches, and farms. The net result is those business that are able to continue will be forced to raise prices which means we all will be paying more for goods and services out of our own pockets.

There are no checks and balances in the Margin Tax Initiative. Although the initiative sets the initial tax rate at 2% and sets the threshold for liability at \$1 million in gross revenue per year, the legislature would have unlimited authority, after three years, to: increase the tax rate, lower the revenue threshold at which it must be paid, or broaden the tax to apply to even more businesses – without any further vote of the people.

Anyone who becomes familiar with this unjust tax will better know how to vote next November. (In writing this I often referred to the *NO on 3: Coalition to Defeat the Margin Tax Initiative*.)

#### Second Annual "We the People" Essay Contest



Friday, April 4, we held our award assembly at Del Webb Middle School to honor the participants in our second "WE THE PEOPLE" essay contest with this year's theme of:

#### The Declaration of Independence: Breaking the Ties That Bind.

One needs only to read the Declaration of Independence to know exactly why WE "dissolved the political bands." It built so logically on last year's theme: "The Bill of Rights in Action" which took us back to our Founders who wanted the lost rights and freedoms that were ignored by King George set down and imbedded in their constitution for all time. This desire led to the inclusion of the Bill of Rights in our U S Constitution. Using the Declaration of Independence as their primary source students were asked to develop their essays including:

- \* What led the Founders to their decision to "dissolve the Political Bands which had connected them to Great Britain?"
- \* How did the Founders view of government differ with King George?
- \* Are we living up to our Founders vision?

  Explain using specific examples, current or historic to support your point of view.

The students' essays showed evidence of using the Declaration of Independence to support their thoughts. Most recognized our nation's imperfections but our winner Ethan Paczkowski said it best. "Despite a few faults, I wholeheartedly believe that based on the myriad of deeds we have done for the world, our founding fathers would be proud of how far that small, isolated republic forged in 1776 has come."

Different points of view were central to our separation from Great Britain. Students were reminded that exercising our rights as a free people requires RESPONSIBLE INFORMED PARTICIPATION. In the words of Greek philosopher Epictitus, "ONLY THE EDUCATED ARE FREE." Therefore, in addition to our student awards our donation to the school library included a DVD and several good historical fiction books all of which present the variety of viewpoints held by the various citizens of the time.

By continuing to sponsor and hopefully to expand our "We the People" contest, we hope to enlighten our youth and spark within them interest in, appreciation of and an understanding of our founding documents.

Veterans Affairs has been extremely active. There is a core of SHRW members who consistently attend the funerals of indigent veterans at the Veteran's Cemetery in Boulder City each month. No one should be laid to rest alone and this is one way we can "give back."



Valentine's week was "National Salute to Hospitalized Veterans." Every year the Sun City Anthem Happy Hookers crochet or knit lap robes for the veterans. Out of the 58 lap robes I made just 4 and Beth Ann Csavre made 10. It takes about 12 hours to produce each lap robe and upon completion we label them with "Made especially for you by the 'Happy Hookers' Crochet Group with tender, loving care and grateful appreciation for all you have done for us. Your service, sacrifice and dedication have not gone unnoticed. May God bless you and watch over you."

It's very moving to see how touched these men and women are when they receive the gift. We even included a couple of baby sweaters and hats in case there were new babies in maternity. Sherri McKay and I started with 58 lap robes and left 57 at the hospital. Driving away we noticed a young vet, a double amputee, in a wheelchair. As we rolled down the window we told him who we were, thanked him for his service and drove off after giving him our last lap robe. I will always remember his smile as he received the lap robe. It is so little to do for those who give so much.

As a Director for the Sun City Anthem Veterans Club (SCAVC) it's my responsibility to send out the Get Well and Condolence cards. I'm also a member of the SCAVC Color Guard which marched in January and February. Just recently a new position was created and I am now a Director of Bereavement. It didn't take long to be in business. A wife of a WWII vet called me quite upset. Her husband was in home hospice care with dementia and her concern was what to do once he passed. I told her that a veteran can have a free burial at the Boulder City Cemetery and that she would need to go to Boulder City with his discharge papers and their marriage certificate. Due to her distress and confusion I took her to Boulder City the next morning where she made all the necessary arrangement.
