On or before May 18th, 2020, the active registered voters will be receiving their ballots in the mail. The returned ballot must be postmarked by June 9th2020.

If you want to vote in person, you can do it at the Clark County Election office located at 965 Trade Drive, Suite F, North Las Vegas. In-person voting will be allowed from May 23rd through June 5th or on the election day, June 9th.
