Primary Election Early Voting May 28 (Saturday) to June 10 (Friday), 2022 ALL EARLY VOTING SITES ARE MAIL BALLOT DROP-OFF LOCATIONS

For coronavirus prevention reasons, some sites may be subject to temporary closure or revised times.
For updates, check our website www.ClarkCountyNV.gov/vote/ or call (702) 455-VOTE (8683).

Any registered voter in Clark County may vote in-person before Election Day at any early voting site.

You may also drop-off voted mail ballots in-person at any early voting site during the dates and hours listed in the schedule. You must still sign the outside of the postage-paid return envelope provided specifically for you, showing your name and address, and seal your voted ballot inside of this envelope before you deposit it in the drop box (do not put your ballot in another voter's return envelope).

If you decide to vote in-person instead of by mail, you will need to do one of the following:

- If you have your mail ballot, surrender your voted or unvoted mail ballot (preferably in the packet sent to you) to an election official at the voting site.
- If you do not have your mail ballot you will sign an affirmation at the voting site swearing that you have not already voted in the current election and that you understand no one may attempt to vote or actually vote more than once in the same election.
