Since 1996, this LGBTQIA+ and Progressive Voter Guide has been produced by Nevadalmpact.com and distributed through various publications and online. While this guide is edited by long-time, human rights activist, Rob Schlegel, it's the work of numerous individuals that know the candidates and research the races. This year's guide will be available in the print edition of QVegas, shortly before the election and should be available online by mid-October at www.Nevadalmpact.com Technically, Nevada Impact is non-partisan but due to the issues we care about, you'll find we usually endorse Democrats – but not always. Our issues include racial, sexual and gender equality, women's right of choice, access to voting, comprehensive immigration reform, a living wage and issues impacting human rights. Because of the nature of our political system, party affiliation is necessary to get most issues passed. Good examples of that would be Nevada's employment non-discrimination act, passed in 1999 or the repeal of the "sodomy law" in 1993. Those are two of dozens of human rights issues that would not have been passed, had the Democratic Party not had the majority in the state legislature. It's also a great argument to vote No on Question 3! We don't want outside money or conservatives deciding which Democrat wins the Democrat nomination. If you want to vote in the primary, register with a party, not as independent. We have more to do, both here in the state and nationwide. The only way democracy can work is if we all vote. While one party may claim "election fraud," and make it harder to vote, it's primarily to discourage you from voting. That allows the radical right, which is a minority, to gain control of our elected offices. Please help save democracy by making sure you vote. Go two steps further. 

State Ballot Questions

State Question Num. 1 - YES

Shall the Nevada Constitution be amending by adding a specific guarantee that equality of rights under the law shall not be denied or abridged by this State or any of its cities, counties, or other political subdivisions on account of race, color, creed, sex, sexual orientation, gender identity or expression, age, disability, ancestry, or national origin?

Yes

A yes vote secures the right of every Nevadan to be treated equally by the state. Those arguing to oppose this measure bring up a bunch of rightwing-radio blather that is totally discredited

State Question Num. 2 - YES

Shall the Nevada Constitution be amended, effective July 1, 2024, to (1) establish the State's minimum wage that employers must pay to certain employees at a rate of \$12 per hour worked,

subject to any applicable increases above that \$12 rate provided by federal law or enacted by the Nevada Legislature. (2) remove the existing provisions setting different rates for the minimum wage based on whether the employer offers certain health benefits to such employees, and (3) remove the existing provisions for adjusting the minimum wage based on whether the employer offers certain health benefits to such employees, and (3) remove the existing provisions for adjusting the minimum wage based on applicable increases in the cost of living?

Yes

While we would prefer things like minimum wage weren't in the Nevada Constitution, the fact is that they are. Minimum wages need to be adjusted as the cost-of-living increases and this amendment will allow for that. Let's vote yes

State Question Num. 3 - NO

Shall the Nevada Constitution be amended to allow all Nevada voters the right to participate in open primary elections to choose candidates for the general election in which all voters may then rank the remaining candidates by preference for the offices of U.S. Senators, U.S. Representatives, Governor, Lieutenant Governor, Secretary of State, State Treasurer, State Controllers, Attorney General and State Legislators?

No

While there are some good arguments for this ballot question, this would allow outsiders to pour money into the state and they could easily snars the top two positions in a primary, forcing voters to decide between the best of two bad candidates. The argument that only party-affiliated voters can decide who runs to represent that party in the general election can be solved by those not-affiliated to simply join a party. Additionally, without the ability to "whip votes," difficult issues such as human rights, likely would not pass if political parties are weakened, which this measure would do. Third party candidates are likely to play "spoiler" to a candidate from an established political party, than to win the election themselves. Odds are, those not affiliated with a particular party wouldn't bother to vote in the primary anyway, so the measure does more harm than good.

If you've seen the huge volume of advertising, featuring a Veteran, claiming 600,000 independent (non-party affiliated). Nevadans can't vote in the primary, ask yourself why they chose to be non-affiliated and then question, "who is paying for those ads?" Don't fall for it. Vote NOT
